- Total project cost £14,000 (WEIF, FIP)
- Completed May 2021

- Complete removal of weir
- Improved 6km of WFD designated Waterbody

# **Rural Diffuse Pollution**

### Land Management Pilot Project

Devon, Cornwall & Isles of Scilly Area

#### The problem

We are seeing ever increasing heavy rainfall events across the Devon and Cornwall. Alongside this, agricultural land is being pushed to its limits in the hope of delivering a profitable business.

The outcome is increased soil compaction and silt-laden runoff, causing pollution of our rivers and flooding of our communities.

The Devon and Cornwall Land Management Pilot aims to respond to this increasing problem of poor land management practices.





How will the project work?

The project team will work proactively across Devon and Cornwall working in areas where soil erosion and runoff have caused environmental incidents.

It is a joint funded project using Flood Defence Grant in Aid and Water Environment Improvement Fund. The team will work with landowners in the first instance but use their enforcement powers when necessary.

#### The Project Team

The 4 person operational team will comprise;

• 1 x Project Manager to coordinate the project.

Environment Agency

- 2 x Project Officers (level 2 warranted) to undertake the field work element.

The team will act on reports from our partners and the general public by fulfilling a regulatory need, dealing with pollution and flooding caused by poor landuse.
